Motion by Schisel, second by Henneman to move into Executive (Closed) Session at 7:40 p.m. Motion carried (7-0).

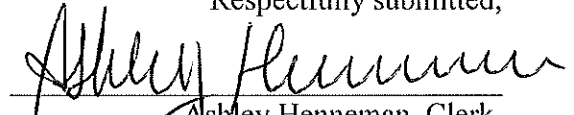
Motion by Schisel, second by Haese to reconvene into Open Session at 8:10 p.m. Motion carried (7-0).
