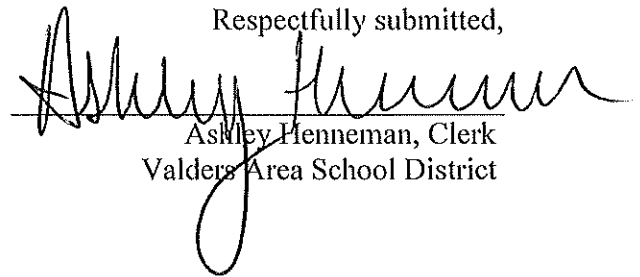
Motion by Lenzner, second by Henneman to move into Executive (Closed) Session at 6:51 p.m. Motion carried (7-0).
